Sub: Approval for establishment of a Government-aided General Degree College in the name of "**Akui Kamalabala Women's College**" at Vill. & P.O. – Akui, Dist.- Bankura, under Bankura University.

Sir,

I am directed by the order of the Governor to convey the "Approval in Principle" of the Higher Education Department, Government of West Bengal for establishment of a Government-aided General Degree College namely "**Akui Kamalabala Women's College**" at Vill. & P.O. – Akui, Dist.- Bankura, subject to the affiliation from **Bankura University**. The college authority must fulfil the following terms and conditions :

1. Submission of Parcha, Mutation / Conversion of Land Certificate is mandatory prior to affiliation from the concerned University in terms of latest UGC Regulations, 2009.
2. At least first phase of the construction of the college building is to be completed within a period of 24 months.
3. The proposed college authority will submit necessary papers related to source of fund in respect of construction / completion of the proposed college building..
4. The college authority shall take necessary steps for completion of the two-storied building within two years.
5. The college authority should arrange at least 1000 books for the college library to start with..
6. The college authority shall strictly follow all the conditions stipulated in the UGC (Affiliation of colleges by Universities Regulations 2009 and other relevant UGC, Rules, Act/Statutes of the Affiliating University and orders of the State Government issued from time to time and submit compliance report as and when necessary.
7. Fees structure will as decided by the Affiliating University / State Government / any other appropriate authority.
8. Academic, administrative and financial discipline has to be strictly maintained.
9. The college may start functioning with Honours & General Degree in **Bengali, English, Philosophy, History and Political Science**.

Considering the demand for the higher education in the area, it is advised that with due concurrence/approval of the Affiliating University, academic activities may be commenced in a suitable building in the locality until such time as the college's own building comes up.

The matter of creation of teaching and non-teaching posts is being taken up with Finance Department from this end. In the meantime, teachers and other employees may be arranged locally after following the due / prescribed procedures and their remuneration shall be met from the College's own resources. While engaging teachers locally, the minimum education qualification / standards specified in respect of college teachers, shall have to be adhered to.
